Contract for a Puppy

It is hereby agreed by both parties as follows, with no other warranties or conditions, either expressed or implied:

The full purchase price of the puppy is \$\_\_\_\_\_.

The purchase price is non-refundable for any reason.

The buyer agrees to pay the airline transportation and shipping fees of \$300.00 for the puppy to be shipped to her, which amount includes the crate. This amount shall be paid 48 hours prior to the puppy being shipped. If this amount is not received by the Seller, the puppy will not be shipped.

The puppy will not be shipped until it is safe for the puppy to be shipped. At this time the airlines are not shipping dogs to the buyers area due to high temperatures. As soon as it is determined by the airlines to be safe for dogs to be shipped to this area, the Seller will ship the puppy to the buyer.

The puppy is being purchased by the Buyer as a Family Pet: ( X ) yes ( ) no

The puppy is a non-breeding Rottweiler. The puppy will be spayed/neuter as soon as of age. The puppy is being purchased for the sole purpose of being a family pet.

The Buyer certifies that said puppy shall reside at his/her home, and the buyer agrees to take proper safeguards for the care and safety of said dog, including proper shelter, food, water, exercise, socialization, proper training for obedience, and have regular immunizations and examinations by a licensed veterinarian, and maintain heartworm prevention and flea/tick prevention. The Buyer agrees that there is no agreement, neither written, expressed or implied, regarding a health warranty on this dog.

The Seller certifies that the above puppy has been inspected by a licensed veterinarian and that a health certificate declaring its free from detectable health problems has been issued. Buyer has 24 hours after taking possession to have the puppy inspected by a veterinarian to determine any serious problems with the dog. In the event your licensed veterinarian determines there is a serious problem with the dog, proof of the examination and explanation of the problem from your veterinarian must be submitted. After verification, a replacement puppy will be issued or the purchase price refunded at the seller's discretion. All costs associated with returning the puppy to Vom Flood Rottweilers, LLC, and the issuance of a replacement puppy shall be assumed by the buyer.

It is further agreed that it is the sole discretion of the Seller to place a puppy with a Buyer. In the event an unforeseen situation should arise, or an incident should take place, or the Seller shall gain knowledge which makes the Seller feel the puppy will not be properly cared for by the Buyer, the Seller has the right to return the non-refundable purchase price, with the explanation that the Seller feels it is not in the puppies best interest to be placed with this Buyer, and at that point, this Agreement shall be null and void.

The Buyer agrees that the name of the puppy shall begin with the letter "A" and shall keep the "vom Flood" kennel name. The Buyer agrees to provide the Seller with the puppies first name prior to the shipment date, and the Seller will register the puppy with the AKC, and forward the Registration Certificate in the Buyers name, to the Buyer, once received from the AKC.

OR

The Buyer agrees that the puppy has been name and has his name registered with the AKC. In the event the Buyer decides to re-name the dog, they agree to keep the registered name and add the new name after \_\_\_\_ (given name) \_\_\_\_\_, ( \_\_\_\_ (given name) \_\_\_\_\_ vom Flood).

The seller does not warrant/guarantee, neither expressed nor implied, the future temperament or personality of the dog. Vom Flood Rottweilers, LLC strives to have quality dogs with regard to bloodline, confirmation and temperament. However, a dog is an individual and a product of its environment. How you choose to raise your dog will be the major determining factor with regard to its temperament/personality. The Buyer is solely responsible for the people, environments, and situations that he/she introduces the dog to voluntarily or involuntarily. The Seller will not be held responsible for any damages, settlements, or judgments resulting from the dog. The Buyer hereby releases from responsibility Vom Flood Rottweilers, LLC, and/or its officers, from any and all liabilities and/or damages by fault of said dog once the dog is in the care and/or possession of the Buyer. These damages and liabilities include but are not limited to destruction of property and physical damage to any person or group of people.

All parties are freely entering into this agreement and are without any mental reservations whatsoever. The Buyer further agrees that he/she is signing this contract at his/her own will, and that he/she is in the proper capacity to be signing this Contract.

The undersigned agree to this contract in its entirety.

The jurisdiction for any action arising out of this contract shall be the state of Georgia with the venue to be Fayette County.

All money paid to the Seller, shall be paid by either cash, certified or bank check, or wire transfer.
